HISTORY OF TVASNAC

- ◆ Established in 1966
- ◆ Comprised of government entities from Town of Hempstead and several Villages
- ◆ Community based organization

ACCOMPLISHMENTS:

- ◆ Strives to make FAA & Port Authority more accountable to communities impacted by airport operations
- ◆ Lobbied State Legislature to pass a law directing the Port Authority to conduct a 150 Study for JFK and LGA.
- ◆ Established the NY Community Aviation Roundtable for JFK and LGA
- ◆ Proponent of a simplified aircraft noise complaint process

BENEFITS:

- ◆ Share information with Village Boards, community groups, residents
- ◆ Raise community concerns to Port Authority and FAA. Let them know we are watching.
- ◆ Mobilize community awareness and action
